Topic: Amendment to Bylaw 15-2021, Lloydminster Wastewater Bylaw.

Background: In September 2021, Council adopted Bylaw No. 15-2021 Wastewater Bylaw to regulate discharges into the sanitary and storm sewers. The Bylaw forms the framework of the City's Pollution Prevention Program. The Bylaw provides the City authority to conduct facility inspections, sample discharges, and impose a surcharge to extra strength effluent.

The Bylaw requires an amendment to further clarify the provisions of the Bylaw and the implementation of the Pollution Prevention Program. The list below identifies the proposed amendment to the Bylaw Schedules.

1. Schedule D
 - Changes in main headings to further clarify applicable parameters, limits, and criteria to Sanitary Sewer and Storm Sewer;
2. Schedule G (as mentioned in Section 6.5)
 - Included to further clarify the information requirements for an "Owner's Report";
3. Schedule H (as mentioned in Section 12.2, 12.6)
 - Included to establish the Fees for Non-compliance Agreements, determination of surcharges, and guidelines for review of surcharges.

Objective: Bylaw No. 15-2021 Wastewater Bylaw requires an amendment to further clarify provisions within the Bylaw.

Options:

1. That the Committee accept this report as information and that the item be brought forward to a future Regular Council meeting for decision.
2. That the Committee request more information and that the item be brought forward to a future Regular Council meeting for decision.
3. That the Committee request more information and that the item be brought forward to a future Governance & Priorities Committee meeting.

Alignment with Strategic Plan: This item is in alignment with the following strategic area: Managing our Environment and Infrastructure. The amendment to the Bylaw No. 15-2021 Wastewater Bylaw will help clarify the implementation of the Pollution Prevention Program which helps mitigate risks to the new Wastewater Treatment Facility and the treatment process.
