**Topic:** What We Heard – RE: Bylaws and Policies pertaining to Lot Grading, Excavation, and Development Security

**Background:** The City of Lloydminster hosted a Your Voice Event on February 28, 2023 from 4:00 to 6:00 pm at the Lloyd Mall to present information on the following:

- Bylaw No. 02-2023, Lot Grading and Drainage Bylaw;
- Bylaw No. 03-2023, Excavation Bylaw;
- Bylaw No. 04-2023, Development Fee Schedule Amending Bylaw;
- Bylaw No. 05-2023, Text Amendment to Land Use Bylaw – Protection of City Property Bylaw;
- Policy No. 610-04, Development Security Policy; and
- Policy No. 610-05, Excavation Policy.

Additionally, Administration sent letters as a public referral to developers, contractors, utility companies, and realtors which welcomed written comments until March 7, 2023.
