**Subject Matter: 2022 Lloydminster Tobacco Reduction Grant Allocations**

**Recommendation:**

That Council approve the grant allocations for the 2022 Lloydminster Tobacco Reduction Grant as follows, and that Council authorize Administration to reallocate any unused or returned grant funds:

Lloydminster Area Drug Strategy: Partnership to Assist in the Cessation of Tobacco (PACT) and Buyback 2021, \$2,900.

Lloydminster Sexual Assault Services: Behind the Smoke - Lighting Up Coping Skills, \$6,000.

Lloydminster Interval Home Society: Luvng My Lungs, \$12,000.

Lloydminster Area Drug Strategy: An Influential Generation & Tobacco Retailers Accountability Course (TRAC), \$7,000.

**Issue:** The Community Services Advisory Committee has reviewed grant applications for the 2022 Lloydminster Tobacco Reduction Grant and provided recommendations for Council approval.

**Background:** In 2022, \$27,900 is budgeted for the Tobacco Reduction Grant to support tobacco reduction initiatives in the community. Fees to support this grant are collected from Tobacco, Flavoured, and Vapour Product Retailer surcharges to promote healthy lifestyles and reducing use of tobacco and smoking products in Lloydminster.

The call for applications opened September 8, 2021 and closed November 1, 2021. Four (4) application requests for funding were received totaling \$38,976. The applications were provided to the Community Services Advisory Committee for recommendations. Guidelines for the grant are outlined in the Lloydminster Tobacco Reduction Grant Policy No. 551-03.

**Options:**

1. That Council approve the motion as indicated in the Recommendation above.
2. That Council request further information and that the item be brought forward to a future Regular Council Meeting for decision.
3. That Council does not approve the recommended grant allocations and direct Administration to release a new call for applications for the Tobacco Reduction Grant.

**Alignment with Strategic Plan:** This item is in alignment with the following strategic area: Providing a Safe Community through funding to a wide-range of service agencies that increase
