Topic: Presented is a draft version of the Municipal Police Committee Terms of Reference.

Background: Recent changes to the Alberta *Police Act* & introduction of the *Police Governance Regulation* (156/2024) requires the City of Lloydminster to create and maintain a Municipal Police Committee. The intention behind the creation of a Municipal Police Committee is to create a stronger connection between the public and the police agency overseeing Lloydminster (Royal Canadian Mounted Police). The creation of this committee requires Terms of Reference to be approved by Council, which an initial draft version is presented today for Council consideration.

Much of the structure contained within the Terms of Reference presented today is legislated through both the Alberta *Police Act* and the *Police Governance Regulation*. Other items follow best practices the City of Lloydminster uses when establishing and maintaining committees.

Key considerations and duties required of the Municipal Police Committee, as required within legislation are:

- oversee administration of the Municipal Police Service Agreement;
- present concerns and interests of the public to the Officer in Charge (RCMP Inspector Nicholl);
- develop a yearly plan of priorities and strategies;
- develop a Community Safety Plan inclusive of a strategy for community and agency collaboration ;
- assist in the selection of the Officer in Charge;
- report annually to the Minister of Public Safety and Emergency Services.

All highlighted portions in the attached draft Terms of Reference are items that are mandated in the provincial legislation.

Objective: The objective of the creation of a Municipal Police Committee is to engage public representation in a more direct manner when making decisions related to policing resources within the City of Lloydminster.

Options:

1. That the Committee accept this report as information and that the item be brought forward to a future Regular Council meeting for decision.
